Notes:

Basic Allowance recognises the time devoted by all councillors to their work, including meetings of the Council, Cabinet, committees and sub-committees, representation of the Council on outside bodies, meetings with constituents and all incidental costs;

Special Responsibility Allowances recognise the time devoted by those councillors who have significant extra responsibilities (eg leadership of the Council and of political groups, membership of the Cabinet and chairmanship of committees), but also reflect an element of voluntary public service;

Co-optees' allowance recognise the time devoted by those co-opted members who serve on the Standards Committee of the Council but who are not elected members of the Council; the allowance also reflects an element of voluntary public service;

All payments made are gross amounts which are subject to deduction of tax where appropriate.
