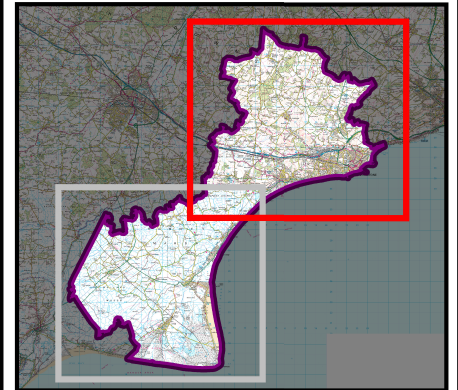


It should be noted that certain locations not shown may be at risk of flooding from other sources (piped drain systems, water mains etc) and from other watercourses not shown in this study.

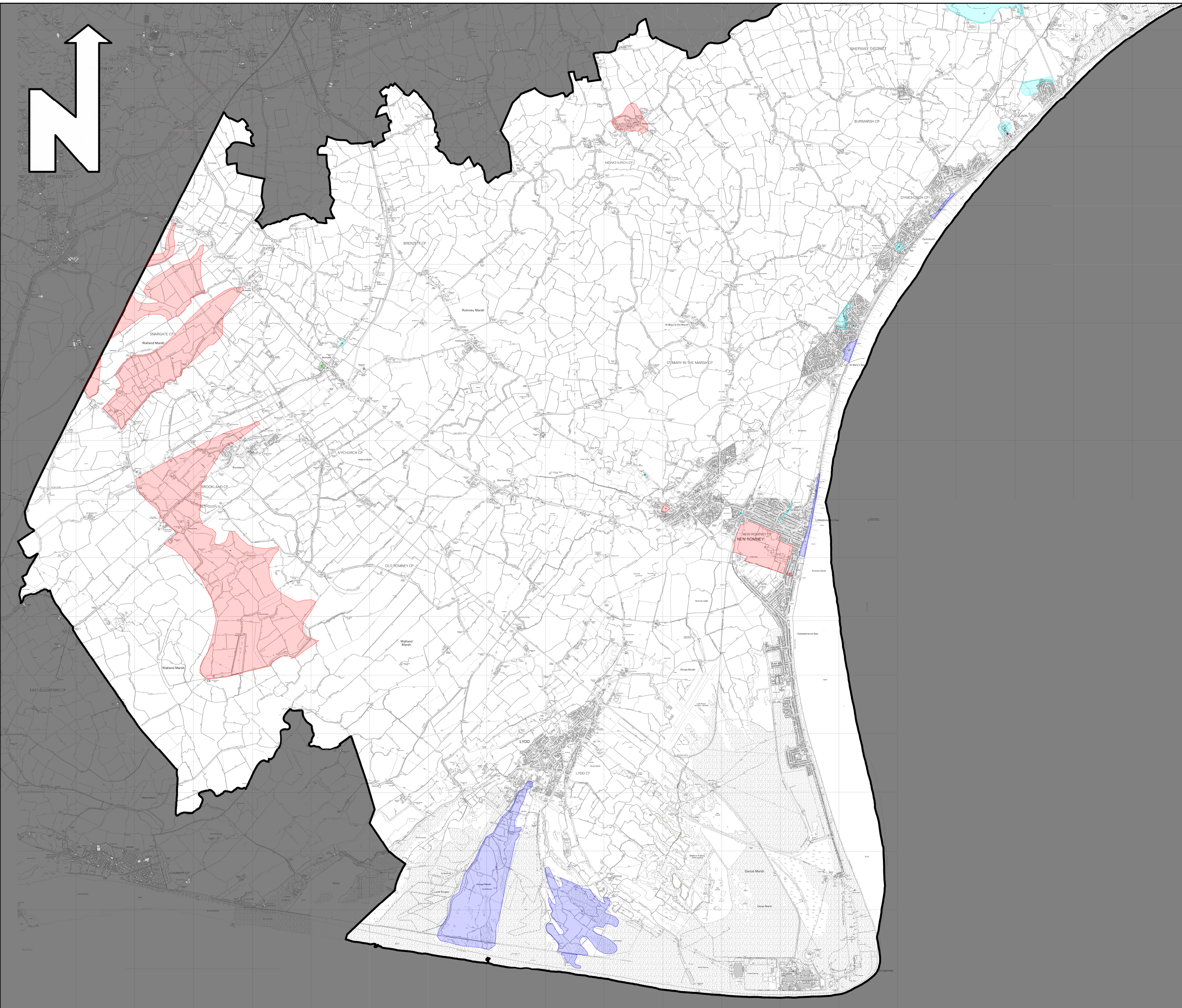

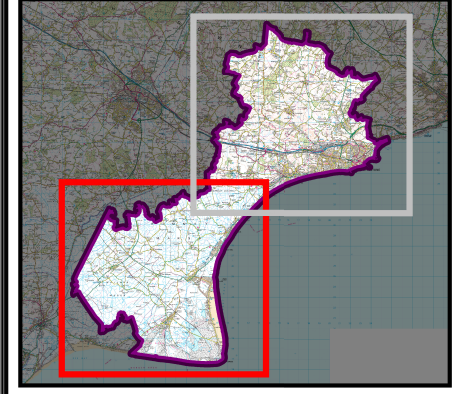
