## Notice to be displayed on site at premises

This Notice must be printed in black ink on PALE BLUE paper.

It must be displayed in a prominent position for 28 consecutive days starting with the day after you give notice of your application to the Licensing Authority, Folkestone & Hythe District Council.

If a premises covers an area of more than 50 metres square, further notices in the same format must be placed every 50 metres along the external perimeter of the premises abutting any highway.

### Notice to be given in local newspaper

The Notice must appear once in a local newspaper, as near to the date after you give notice to the Licensing Authority, Folkestone & Hythe District Council of your application

After this has been published this Notice must be cut out of the newspaper and sent into the Licensing Authority as part of your application (Licensing Team, Civic Centre, Castle Hill Avenue, Folkestone, Kent CT20 2QY)
