Nomination Papers



What is a nomination?

- A declaration to stand for election
 - Area
 - Support
 - Consent and criteria
 - In what capacity Independent / Party
- Taken at face value
 - What you declare is true to the best of your knowledge



Qualifications to stand for election

- At least 18 years old on the day of nomination
- A British citizen, an eligible Commonwealth citizen or an EU citizen with retained rights, who does not require leave to enter or remain in the UK or has indefinite leave to remain

....and

You fulfil at least one of the criteria on a nomination paper



When and where

- Nominations start: Monday 24 March 2025 at 10am
- Every working day there after between 10am 4pm
- Nominations close: Wednesday 2 April 2025 at 4pm
- Hand deliver to:
 - Customer Access Point, Folkestone & Hythe District Council, Civic Centre, Folkestone, CT20 2QY



Descriptions

At county elections your description can only be, either:

- left blank;
- the word 'Independent';
- the registered party name of a registered political party; or
- one of the descriptions the party has registered with the Electoral Commission.

The registered party description must be no more than six words in length.

If you intend to stand with a registered party, you must have their authorisation to use their description and emblem



The Consent To Nomination form

I declare that on the day of my nomination, I am qualified and that, if there is a poll on the day of election, I will be qualified to be so elected by virtue of being on that day or those days a qualifying Commonwealth citizen, a citizen of the Republic of Ireland or a citizen of a Member State of the European Union, who has attained the age of 18 years and that:

*a. I am registered as a local government elector for the area of the *county/district/London borough named above; or

*b. I have during the whole of the 12 months preceding that day, or those days, occupied as owner or tenant land or other premises in the area named above; or

*c. my principal or only place of work during those 12 months has been in the *county/district/London borough named above; or

*d I have during the whole of those 12 months resided in the *county/district or London borough named above.

Agent notification form

Must be a physical address, within the council area.

IMPORTANT!

If you are your own agent and are using your home address as your office, it will appear on the Notice of Election Agents. It will be published even if you have withheld your home address on the ballot paper and statement of persons nominated.

It is beneficial to provide contact information in case we have a query or follow up with your papers. KCC would like to collect all candidate email addresses as well.

Original copies

All forms must be the original document Photocopies will not be accepted

If you have pre-printed emblem certificates, they must be the original and contain a wet signature, not a printed signature or photocopy.

Agents

- Election Agents
 - Responsible for election campaign and return of expenses
 - Single point of contact for Candidate(s)
- Polling Agents
 - Attend the polling station on your behalf
 - Observe process
 - Can mark a copy of their own register
 - A marked register can not be removed until close of poll
- Postal Vote Agents
 - Notify Paul before opening session begins
 - Maximum of 1 per candidate

Verification and Count

Verification

- Six tables, each with one county division:
- Ballot boxes from stations
- Ballot boxes from postal vote opening sessions
- Count polling station ballot paper, papers (not votes)
- Count postal ballot paper, papers (not votes)
- Reach a verification figure from accounts
- Figures are accepted by the Deputy Returning Officer
- Ballot papers are put back into their box
- Verified label inserted in the front

Count

- Once all divisions are verified the count can begin
- Polling station and postal boxes are mixed
- Supervisors collate votes figures and reconcile
- Deputy Returning Officer approves votes counted
- Declarations are made



Election expenses

- Responsibility of the Election Agent
- Submit expenses to the County Returning Officer:
 - c/o Elections Team
 - By Friday 6 June 2025
 - Preference via email: <u>elections@kent.gov.uk</u> (scanned copies)
 - Via post: Lesley Warren, Sessions House, County Hall, Maidstone, ME14 1XQ
- Spending limit: £960, plus 0.08p per local government elector
